

## SPECIAL SERVICES

Specialized treatment programs provide offenders the skills necessary to lead productive, crime-free lives. Employment opportunities exist for probation and parole officers serving in the Eighth District's Sex Offender Treatment Programs, Drug Courts, Mental Health Court, Reentry Program, and Iowa Domestic Abuse Program. Other positions include ILEA-certified officers in the High Risk Unit, who conduct home visits and office safety checks, a victim services provider, and a psychologist.

## RESIDENTIAL SUPERVISION

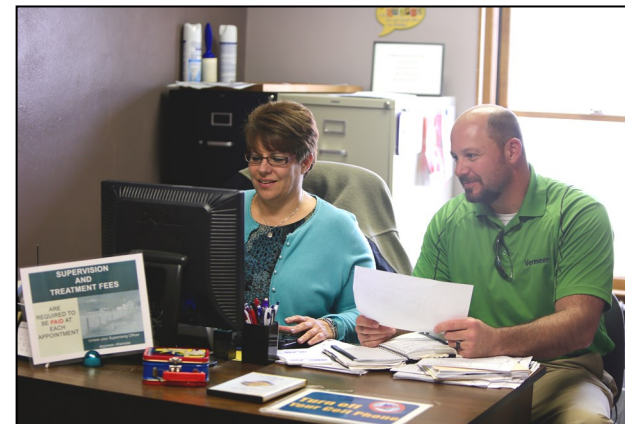
The Eighth District maintains residential correctional facilities in Burlington and Ottumwa, respectively. The facilities are staffed by residential officers charged with monitoring offenders as they transition back to their communities from prison, or after being ordered to a facility as a sanction. Residential officers administer drug and alcohol tests and conduct employment, treatment and furlough checks, as well as monitor general offender compliance. Internships are available.

## PROBATION AND PAROLE

Probation and parole officers in the Eighth District are located throughout 14 counties in southeast Iowa with the primary offices located in Burlington and Ottumwa. Probation and parole officers conduct regularly scheduled face-to-face meetings with offenders, develop individual case plans based on ongoing risk and needs assessments, and are ultimately responsible for monitoring offender compliance with all supervision and treatment conditions established by the courts.
